HS2 has problems in a parallel world in the USA By Richard Deacon

I saw this recent article in the New York Times while I was off Alaska in August last.

"\$11bn later, High Speed rail is inching along"

WASHINGTON- High speed rail was supposed to be President Obama's signature transportation project, but despite the administration spending nearly \$11bn since 2009 to develop faster passenger trains, the projects have gone mostly nowhere and the US still lags far behind Europe and China.

While Republican opposition and community protests have slowed the projects here, transportation policy experts and members of both parties also place blame for the failures on missteps by the Obama administration- which in July asked Congress for nearly \$10bn more for high speed initiatives.

Critics say that the \$11bn has instead been spent on upgrading existing Amtrak services allowing trains to go no faster than 110mph. None of the money went in the Northeast Corridor, the most likely place for high speed rail.

On the New York to Washington route the Acela averages 80mph and a plan to take it up bullet train speeds of 220mph will take \$150bn and 26 years if it ever happens.

Florida, Wisconsin and Ohio cancelled high speed projects and returned federal funds deeming the projects too expensive and unnecessary.

When Obama first presented his vision for high speed rail, he described a future of bullet trains hurtling passengers between far flung American cities at more than 200mph. In 2011 at his State of the Union address he said "Within 25 years, our goal is to give 80% of Americans access to high speed rail."

That notion was "unadulterated hype and it didn't take an expert to see through it " said Kenneth Orski editor of an influential transportation newsletter who had served in the Nixon and Ford administrations.

A—The photo was taken from the north end of Crewe Station in 1906 looking towards North Junction, with the narrow gauge




railway that ran from Crewe Station to Crewe Works running THROUGH Crewe North Junction Box.
