Private Policy Notice

1. Use of data

The N&DMRC uses the collected data to administer the organisation.

In addition the e-mail addresses of the Contact are used to circulate notices of N&DMRC organised Events, club information and news, the clubs newsletters (which may also be sent to other e-mail addresses held for Organisational and Commercial Associates).

Notices of events organised by other N&DMRC Members are distributed to the Contact's e-mail address.

Items of railway or modelling interest are distributed to the Contact's e-mail address. The N&DMRC's primary method of contact is by e-mail.

2. Sharing data outside of the N&DMRC.

The N&DMRC does not share data with any organisation or individual that is not an associate of the N&DMRC.

3. Sharing data within the N&DMRC.

Personal data relating to Individual Members is exchanged within the Club to other Individual Members only. All other requests for data will be on an Ad-Hoc basis seeking written permission from the Individual Member(s) concerned.

On joining the N&DMRC you will be provided with a Data Usage Consent form for completion. This form outlines your wishes as to how the Club will communicate with you, and use the data you have provided.
